ELIGIBILITY

Eligible Students are:

- Between ages of 5 -21
- Attending a school within Los Angeles County
- Under the jurisdiction of Los Angeles County Dependency Court/DCFS
- And/or under the jurisdiction of the Los Angeles County **Delinquency Court/Probation**

Non - Eligible Students are:

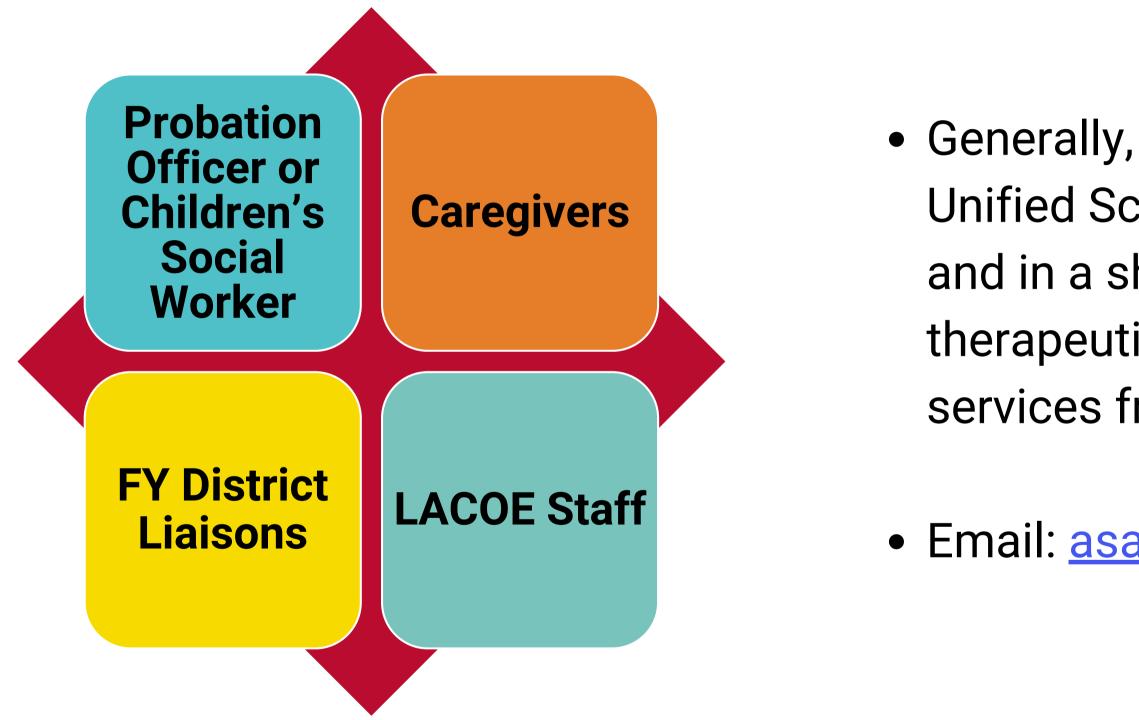
- Receiving services from Regional Center
- Kin-GAP

Submitting a Tutoring Referral





WHO CAN SUBMIT A REFERRAL





• Generally, students residing within LA **Unified School District boundaries** and in a short-term residential therapeutic program (STRTP) receive services from the district.

Contact the caregiver to ensure:

- student's interest in services.
- caregiver support of services.
- the student isn't already receiving services from another program.
- this is not a consumer of the Regional Center.

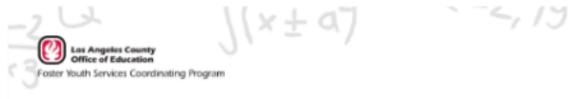

ACADEMIC SUPPORT SERVICES

Academic support services are available to students in foster care or those on probation via LACOE's Foster Youth Services Coordinating Program.

The 2024 - 2025 online tutoring referral is open.

Referrals are submitted online through our FYS tutoring site (see reverse side for instructions). Eligible students may receive up to 21 hours of in-home, one-on-one tutoring each school year.

REQUIRED INFORMATION

The following information is required to submit a tutoring referral:

- Caregiver Contact Information and Consent
- Student Information: name, date of birth, gender, grade level and courses
- Placement Type: and if applicable, the name of the STRTP/group home, or foster family agency
- Court Status: open Juvenile Dependency (WIC 300); open Probation/Delinquency (WIC 602); Dual Supervision; or Non-Minor Dependent
- Los Angeles County Representative Contact Information: Children's Social Worker (CSW) and/or Los Angeles County Juvenile Probation Officer (PO) information
- County Office Name

Please Note:

Requests for higher-level courses require proof of coursework prior to services being provided.

Missing or incorrect information will delay the referral process.

Step 1: Visit our <u>webpage</u> or scan the QR code to submit a referral

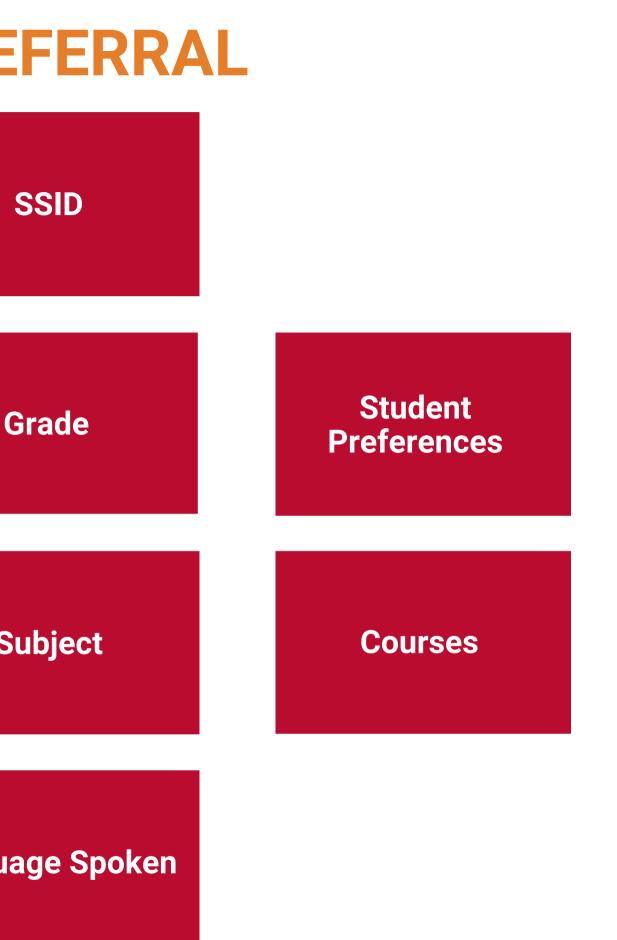

TUTORING APPLICATION PROCESS

1. Visit LACOE Tutoring Webpage: LACOE FYS TUTORING



LACOE helps connect students in foster care that need additional academic suppor with tutoring resources.



- 2. Scroll down to locate Submit a Referral
- 3. Enter the student's name, date of birth and 10-digit SSID. Verify the correct name is populated and select
- 4. Complete the required information and click the *Next* button
- 5. Read the statement and click *Certify* to submit the referral
- 6. Once the tutoring referral is submitted, the referrer will receive a confirmation email

- You have entered the correct SSID
- You have entered the correct name
- You have the correct birthdate
- You are using Chrome as your browser
- You are logged out of EPS

ASSIGNING A REFERRAL

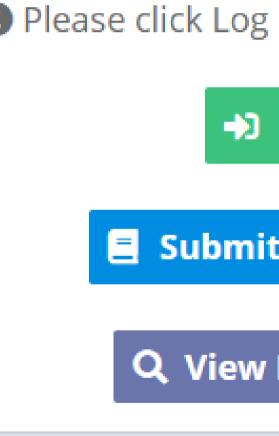
- If a referral is considered incomplete, the referrer will receive an email from fys_tutoring@lacoe.edu requesting they submit a new referral
- Information is reviewed and assigned to a tutoring vendor
- Once the vendor receives the referral they will assign it to a tutor within 10 business days

REFERRAL STATUS

- Submitted

Terminated

- Services refused by caregiver or student
- Tutoring vendor unable to contact caregiver/household
- Placement change leading to ineligibility or vendor unable to provide services
- Student receiving tutoring from another source
- If terminated, a Letter of Termination will be sent to either CSW or DPO and referrer



Who qualifies? **Q**:



- Funding for Foster Youth Services can only be used for A: students:
 - ages 5-21
 - Attending a School within Los Angeles County • residing within Los Angeles County open DCFS/Dependency Court and/or open probation/Delinquency Court Case

 - (College students with open cases may receive tutoring if they continue to have an open case through the age of 21)

When do you stop accepting referrals? **Q**:

- A: We will continue to accept referrals as long as our budget allows. Once we have reached capacity the turoing referral will no longer be available.
